RULES & REGULATIONS

1. **ELIGIBILITY:** Contest is open to all U.S. residents 18 years or older who have paid the Live Aloha Musubi Eating Contest Fee of \$10.00 CASH (payable at Live Aloha Festival) and completed the Entry Form (submitted via email or mail). Employees and Volunteers of the Live Aloha Hawaiian Cultural Festival, Seattle Center, Live Aloha Hawaiian Cultural Festival Sponsors, Vendors, members of the festival and the members of their immediate families are not eligible to enter. Void where prohibited.
2. **TO ENTER:** READ CAREFULLY THIS OFFICIAL CONTEST RULES AND ENTRY FORM FOR THE LIVE ALOHA MUSUBI EATING CONTEST INCLUDING THE ELIGIBILITY REQUIREMENTS AND WAIVER OF LIABILITY PROVISIONS. Complete and sign this Entry Form. All Entry Forms become the property of the Live Aloha Hawaiian Cultural Festival.
3. **CONTEST RULES:** There will be ONE (1) competition for all qualifying Contestants. Contestants will compete for one (1) Grand Prize. The contest will be conducted on September 11, 2016 at the Live Aloha Hawaiian Cultural Festival at Seattle Center's Mural Amphitheatre at 5:00 p.m. Time is subject to change without notice.
 - a. Contestants must have a clean appearance for the event. If the Live Aloha Hawaiian Cultural Festival Committee deems a Contestant's appearance and/or clothing is inappropriate, the Contestant may be subject to disqualification. Entry is limited to first 8 eligible Contestants who have paid the \$10.00 Cash Entry Fee and completed the Entry Form. Entries may be received by U.S. mail or email. (Entry Form submittal information below.) Contestants must check-in at the Armory Information Booth NO LATER THAN 4:40 p.m. on September 11, 2016. Upon checking in, Contestants will be provided contest instructions and directed to a designated Contestant waiting area. The contest will start at 5:00 p.m.
 - b. A Contestant will forfeit their place should they fail to check-in at the Armory Information Booth NO LATER THAN 4:40 p.m. on September 11, 2016 and/or fails to be continuously present for the duration of the contest. Contestants will also forfeit their place if they leave the waiting area after checking in.
 - c. The object of the contest is to eat as many musubi as possible within 2 minutes. The Grand Prize winner will be the person who ate the most musubis. Credit will be given to partially eaten musubi.

- d. Contestants must wait for the starting signal to begin eating and may not touch any part of the musubi prior to the starting signal.
- e. Contestants must stand during the contest and may use their hands. The use of utensils is NOT allowed.
- f. Condiments are allowed and must be provided by the Contestant.
- g. Contestants will be allowed to use and/or drink bottled water during the competition. One bottle of water per contestant will be provided by the Live Aloha Hawaiian Cultural Festival.
- h. Contestants must completely finish one (1) musubi before picking up the next musubi.
- i. The contest is over when the ending signal is made. Contestants must immediately stop eating and place their hands at their sides at the ending signal. Contestants may not put their hands to their mouths or put any additional food in their mouths after the ending signal. Contestants will be given 15 seconds to swallow what is already in their mouths. If a Contestant throws up or regurgitates, Contestant will automatically be disqualified.
- j. Judges will be on hand to assure adherence to contest rules, monitor the “no throw up or regurgitating” rule, and to disqualify contestants who fail to adhere to the rules.
- k. Winners will be determined by the judges, based on the number of musubi eaten. In the event of a tie, the decision of the judges will decide the winner of the event.

Grounds for disqualification include:

- False or incomplete entry form or liability waiver
- Any health risks that could jeopardize the contestant’s health or wellbeing
- Under the influence of any substance
- Appearance is deemed inappropriate
- Failure to check-in at the information booth by 4:40 p.m. on September 11, 2016
- Starting prior to the start signal
- Throwing up or regurgitating

Note: The Live Aloha Hawaiian Cultural Festival reserves the right to disqualify any contestant for any reason without explanation.
